Legal Description. A non-profit, non-stock corporation chartered by the State of Delaware on April 1, 1965.

Please enroll me as a member in the following category:

_____ **Builder:** Any individual, partnership or corporation which for a period of two years has been actively engaged in the building or surfacing of tennis courts, running tracks, indoor sports facilities, natural or synthetic turf sports fields, or other athletic or recreational surfaces, or the installation of products or components related thereto, shall be eligible to be a Builder Member of the Association. For the purposes of this section V.I.a. "building" means taking contractual responsibility for the construction of some portion of the project. Any applicant shall be deemed to meet the requirements of the foregoing sentence if a majority of the voting control of the applicant shall be held by individuals who at the time of the application are designated by the Association as a Certified Tennis Court Builder or a Certified Track Builder. Annual Dues — \$840.00

_____ **Supplier:** Any individual, partnership or corporation which, for a period of two years, has been actively engaged in the manufacture for resale or distribution at wholesale of materials, hardware or accessories used in the construction of tennis courts, running tracks, indoor sports facilities, natural or synthetic turf sports fields, or other athletic or recreational surfaces, and does not meet the qualifications for Builder membership, shall be eligible to be an Supplier Member of the Association. Annual Dues — \$1,120.00

_____ **Professional Member:** Any individual, partnership or corporation which is engaged in the business of rendering professional design or consulting services on a fee basis in connection with the construction of tennis courts, running tracks, indoor sports facilities, natural or synthetic turf sports fields, or other athletic or recreational surfaces, and is qualified under state law to do so, or the rendering of technical, testing, advisory or consulting services related thereto, shall be eligible to be a Professional Member of the Association. Annual Dues — \$500.00

_____ **Provisional Member:** Any individual, partnership or corporation which would otherwise be eligible to be a Builder or Associate or Affiliate Member of the Association but which does not satisfy the two (2) year business requirement as shall be eligible to join the Association as a Provisional Member. Provisional Members shall not be eligible to vote on matters coming to a vote of the Members of the Association, shall not be eligible to use the collective membership mark, and shall not be eligible to hold any office of the Association or any of its Divisions. The membership category of a Provisional Member shall automatically be converted to the appropriate category upon satisfaction of the two year business requirements. Annual Dues — \$450.00

_____ **Ancillary Member:** Other parties, which though not coming in any of the foregoing classifications, are interested in helping to fulfill the purposes of the Association shall be eligible to be Ancillary Members of the Association. Examples of Ancillary Members are trade publications and associations. Ancillary Members shall not be eligible to vote on matters coming to a vote of the Members of the Association, and shall not be eligible to hold any office of the Association or any of its divisions. Annual Dues — \$450.00

Note: A member which qualifies in more than one category should participate as a member in the category which corresponds to its principal business, but may participate in additional categories by the payment of additional dues.
